**The following address the requests made by the Grant Road Coalition at the September 29, 2015, Coalition**

**Meeting.** Rebecca Ruopp, Office of Integrated Planning, agreed to work on fulfilling the requests during the week of October 5, 2015. The Tucson Department of Transportation and the Pima Association of Governments assisted in gathering the information.

**REQUEST: Copy of the 2010 Noise Study: Status:** A copy of the full noise study, from which the information on noise presented in the Design Concept Report (DCR) was taken, was requested from Kimley-Horn, the consultant who conducted the noise study. Here is the link:

**REQUEST: Presentation by a professional with expertise in noise impact analysis and mitigation to help neighborhood understand the findings of the 2010 noise study.**

**Status:** The consultant who undertook the noise study is not part of the current project team. The City has asked the consultant to provide an estimate on what it would cost to have the consultant review the document and prepare a presentation for the Coalition. Staff expects to receive that cost sometime next week (week of Oct. 12). Because this is not a cost that is covered by the RTA budget for Grant Road, we will need to determine how the cost might be covered.

**REQUEST: Projected estimate of increase in traffic on Grant Road following completion of project?**

**Status:** The Pima Association of Governments has projected Average Daily Traffic (ADT) numbers for 2045, and has provided the ADT numbers for Grant Road between Oracle Road and Swan Road in the Excel spreadsheet attached. Also attached is some information about the Demand Model used in preparing these projections.

**REQUEST: Intergovernment Agreements (IGAs) with RTA and Advanced Acquisition Agreement.**

**Status:** These documents have been provided by Jim DeGrood, Deputy Director, Pima Association of Government (PAG), and are attached.

**REQUEST: Printed copy of Phase 5 map.**

**Status:** Grant Road Citizen Task Force Member, Andrew Jones, who attended the September 29<sup>th</sup> Coalition meeting and heard this request, kindly printed out the maps, taped them together, and provided them to Joan Daniels at the September 30, 2015, Grant Road Task Force meeting. (*accidently wrong set of maps...Joan will undertake on own*)

**REQUEST: Copy of Phase 2 100% Plans.**

**Status:** Working 100% plans will be presented at the October 27, 2015, Open House at which staff will answer questions and receive comments. The pdf of these plans will be posted on the Grant Road website within two weeks after the Open House. Following that the City will undertake final reviews of the plans, with the final 100% detailed plans being available by the beginning of the New Year at which time large copies of the plans will be provided to the Coalition.
